

Recently we witnessed our community unite in generosity to support neighbors struggling from cuts to the Supplemental Nutrition Assistance Program.

Our team at the Volusia Sheriff's Office and Daytona Beach Police Department, along with community partners like the Jewish Federation of Volusia and Flagler Counties and Daytona International Speedway, stepped up to the challenge and organized the food drive in just a few days.

Saturday, November 8, was collection day. I cannot thank each and every volunteer enough for showing up and spending their Saturday sweating under the sun to organize and bag food items. The donations were graciously donated by big grocery stores, businesses, wholesalers, and countless individuals who opened their hearts to help families in need.

Sunday, November 9, was distribution day. The turnout we witnessed throughout the day highlighted the need. In fact, people waiting in line were running out of gas while waiting. Wrecker trucks arrived to help and offer these individuals gas. A small but powerful example of the generosity that filled the day.

Along with the food donations, we were able to raise \$70,000 for the event. The donors and volunteers are too numerous to list here, but each and every one of them made a difference.

Without the support of everyone, this event would not have been possible.

"This is a miracle that we're all a part of, and how often do you get to witness a group miracle," said Rabbi Dr. Robert B. Lennick from the Jewish Federation. "This county has shown up in the most incredible way beyond our expectations, and we're just grateful we all get to be part of this blessing."

The day after distribution day, we got the good news that Congress was finally making progress to end the federal shutdown and resume SNAP funding in full. Still, at a time of uncertainty for so many families, we estimate we were able to reach 3,500 households, including kids, seniors, working parents, single moms and dads, and veterans.

Thank you, Volusia County, you showed up and you showed out. You exceeded our wildest expectations.

NEIGHBORHOOD ACTIVIST

Dear Bellaire Friends and Neighbors:

I have asked our Commission many times to discuss issues, rather than keep things fluffy and they sure did that at the last meeting. It wasn't pretty for sure - but most real issues are not. These were issues that affect all of us as taxpayers. First up was the use of the purchase order cards. Commissioner Cantu has evidently been looking into this - particularly at the F3 managed Marina, an Enterprise Zone for the city. A PO card can be issued to employees, vendors, contractors, staff and the Commission. In my opinion sometimes these cards can be useful by making small purchases easier, and smoother, without a lot of paperwork, but at its worst the process in place now could be rife with the opportunity for misuse and fraud.

I remember our Charter review from 2004. I spoke at every opportunity to ask for a monetary limit on consent agenda items. I still think that's a good idea. I am bringing this up now because I believe a much stricter policy (monetary) should be in place regarding the use of these cards. Who should have them? What should the limits be? I don't think vendors or contractors should willy-nilly have use of the cards. Certainly at least 10 people, some with two cards at the Marina, appear fishy to me. I hope our internal auditor will be able to access records quickly and report on what he finds.

And the second issue that was brought up was the use of our permits and licensing fees. The Mayor, City Manager, Asst City Manager and the Permit and Licensing Director were summoned to Tallahassee to explain what was happening with what the state considers excess fees. I do have questions. There are other cities who have been collecting fees at a rapid pace. Why weren't they also called to testify - or did they do everything correctly according to Florida's seemingly arbitrary law that mostly favors developers? Why didn't our own representatives try to help our city more, rather than humiliate and threaten them? How did they get hold of work documents (drafts)? Why did they treat them as



evidence of corruption? Even I do drafts of documents before hitting send or a final product is reached, don't you? I smell a mole that is more interested in Tallahassee and developers than in our city. I hope these issues get worked on quickly and solved. Not talking about it publicly and in detail is one of the reasons we are where we are, I think. Let's get it settled.

By necessity, the deadlines for submitting my column for print for this newsletter sometimes make for awkward timeliness in that new info may come in that may change what I decide to write about and what I think about an issue - I like as much information as I can get while forming an opinion.

This month I am remembering what it is to be thankful for in my own life and to remember and help out others who aren't quite so lucky.

Again, I want to thank you for the opportunity to express my opinions.

JUST SAY NO!

In January 2023, the City Commission approved a change to the Land Development Code that allowed an Event Center as a Special Use in residential zoning areas with specific caveats to protect residents. Event Centers were required to be 250 feet from any adjacent residential use; they were not to exceed 7500 sq. ft., parking is to be on the side or rear of the property; capacity cannot exceed 500 patrons; the center cannot operate between midnight and 8:00 a.m.; and an Event Center is to be a private, indoor, entirely enclosed structure. The Commission also allowed an Event Center as a PD (Planned Development) which, according to the Planning Staff report, was to enable Event Centers to fit into existing shopping centers in commercial and business zoning areas...NOT to be used to place in a residential area with the ability to ignore and override ALL residential protections. Additionally, the city's Comp Plan states for Neighborhood B (between Glenview and University) that the City shall maintain the residential character of riverfront property. (The Daytona Playhouse, with seating for 250 people, was built in 1946, long before this policy was put in the code.) The city is also, per the Comp Plan, to maintain its Historic Districts. Finally, according to Federal and State statute as well as the city's own code, Event Centers are NOT to be confused with Community Centers, which are open to the public and owned/operated by a nonprofit group or a public agency, i.e. local government. Event Centers provide for activities that are operated or carried on for financial gain.

Why does any of this matter? Because an Ormond developer who let his previous PD zoning, meant to build residential condos, expire 3 times over a period of 15 years, the last time with the Commission stating they would not renew it again, has come forward with other agents, to try and call what is clearly an Event Center a 'Community Center' in a ploy to sneak in a use that is 100% detrimental to residential areas. They have

said, ON THE RECORD, that their 'community center' is available to anyone who wants to lease/pay to use it...in other words - an Event Center strictly for the owner's financial gain. They also propose a 3 story, 12 unit, 5100 sq.ft. apartment/guest building for people coming from out-of-town. The proposed site is 810 N. Halifax, the vacant lot at the corner of Riverview Blvd and N. Halifax on the river.

How does it NOT MEET the city's planning code:

It's a 2 story; 24,204 sq. ft. building - MORE THAN 3 TIMES THE ALLOWED SPACE IN A RESIDENTIAL AREA!

That's 6000 sq. ft. bigger than the largest ballroom in Daytona which is the Coquina Ballroom at the Hilton. The Coquina holds 2000 people.

It is NOT a totally enclosed building. There is an outside riverfront deck that's an additional 2086 sg. ft. and seats 140 people. There's also a separate paver patio for guests that's 4750 sq. ft.

It is approximately 32 feet away from adjacent home sites on all sides - NOT THE REQUIRED 250 feet away!

They state their total guest capacity is 522. That is apparently not including the extra 140 seated on the raised deck and there are no numbers given for the 4750 sq. ft. outdoor paver patio.

They have a large, indoor elevated stage (900 sq. ft.) about 20 ft. from the back patio doors.

WHY DOES ALL THIS OUTDOOR SPACE AND STAGE MATTER? Because it's on the water. Sound travels 4 1/2 times faster over water than land which means it will reach N. Halifax & Pelican in 1.2 seconds! Sound also travels farther, faster and is even clearer when traveling over water at night.

There are only 143 parking spaces for event and apartment guests as well as all necessary staff. Five are handicap spots. Just to fit 522 hall guests and 140 outdoor deck guests means people have to arrive packed with 4.6 people per vehicle, including handicapped and

NOT including staff. That does not include apartment guest parking.

When serving alcohol, an establishment may stay open until 3:00 a.m. - ignoring the 'special use' requirement to not operate between midnight and 8:00 a.m.
