Greetings, friends and neighbors, I hope your Holiday Season finds you surrounded by loved ones.

Because the present leadership team is stepping down at the end of 2025, our November meeting took on a different process. As was advertised, instead of our usual guest speaker format, the well-attended meeting had BCG members engage in an open discussion regarding the future of the Bellaire Community Group.



First off, Nancy and I expressed our gratitude to all the wonderful volunteers and incredible joy that the last 20+ years have given us. I spoke of our past Chairman Steve, when in our discussions we decided that the critical part of BCG was that it was to be a community group, not a neighborhood watch group. We did not want the group to pit neighbor against neighbor. We also decided that BCG would not endorse any political candidates for the same reason. Instead, we decided to have political forums inviting all candidates, disseminating their platform, and have confidence in our membership to think for themselves and make their own decisions. Looking back at the last 20 successful years of BCG, I think these decisions have proven to be wise.

I am happy to report that the meeting was well attended: there was a lively discussion, and one thing that was made clear is that the members want BCG to continue. Discussion topics included whether to form a 501 corporation, the costs of the monthly newsletter (most were surprised that the costs are less than 650 dollars a month), and the costs and need for the continuation of preparing and serving meals each month. What became very clear is that over the 20 years, BCG has developed into an organization with many moving parts...most of which has been managed by Nancy. Nancy, thank you for your incredible service to our neighborhood.

The results of the meeting were that further discussion was needed. A committee of volunteers was established. Larry McDermott stepped forward with an outline of a plan and agreed to schedule further meetings to determine how BCG would move into the future. Thank you, Larry.

Our December meeting will be our Annual Christmas Party. See you all then, Merry Christmas, Happy Hanukah, and Happy Holidays.

#### A NATIVE REMEMBERS

Well, it has been more than 20 years since I have been writing about my memories about living here for more than 75 years. These screeds have for the most part been a joy to write. They have allowed me to dig deep into my brain to recall many happy times in my life. Thank you to those who have enjoyed reading them, and have taken the time to write, call, or tell me in person that you have enjoyed reading them ...that was the point. I wanted to share my recollections of what was like to grow up here.

Daytona Beach was very different in the 1950s. Much of my childhood memories are very much a Norman Rockwell painting. I grew up on a dirt road, with woods, orange groves, and cattle ranches, and the Halifax River was still some place you could swim. That area is all developed suburban neighborhoods now. Central Florida's climate is a magnet for what seems to be an unstoppable migration-- and a population explosion that makes these memories more precious.

My more recent memories include running for both Daytona Beach City Commission Zone 2 back in 2004. That loss actually led to me founding the Bellaire Community Group. I spent 10 years as President of Sons Of the Beach advocating for the continuation of beach driving; one of the most enjoyable memories of my life was being able to drive down the beach 24 hours a day 7 days a week. Those 10 years with the Sons Of the Beach were great fun, including suing the county for violating their own county charter and meeting some of the most dedicated citizens in Volusia County. I ran for County Council in 2021 and had to drop out for health reasons, a heart stent.

Being part of the leadership of the Bellaire Community Group has been a constant in my life for over 20 years. The leadership team included Steve Koenig, Nancy Koenig, and Megan O'Neill. Megan is the



unsung hero and editor of our monthly newsletter. Megan always makes us smarter. For 20 years, the 4 of us collaborated happily with one another. I don't remember one disagreement. What a privilege it has been. There are many great memories with these folks through the years. One of the best is the 10 years that Steve, Weegie Kuendig, and I would make our monthly appearance on former Volusia County Chairman Big John's radio show.

Making these BCG memories has been some work, but great fun. It has been the volunteers that have made BCG work. Our street captains who deliver the Newsletter, our monthly newsletter contributors, our volunteer kitchen staff, and the Schnebly Rec Center staff,,,thank you is just not enough. A special thank you to charter member Frank Stein, our 50/50 raffle man and greeter.

It is my hope that BCG will continue as the four of us have intended it to be: a neighborhood group that provides information from our community leaders and is a welcoming group to all who live in our area. As Steve would say, THANK YOU FOR THE JOURNEY.


